2. method of data processing (incl. legal basis)

In connection with the application and - in case of acceptance of the application - the membership administration, personal data are processed. According to Article 4 No. 1 DS-GVO, personal data are all data relating to an identified or identifiable natural person. Only employees of KIT / the Graduate School authorized for this purpose have access to the data of the application procedure and membership administration. The data processing is based on Article 6 para. 1 lit. e, para. 3 DS-GVO and §§ 12 para. 1 p. 1, 2 para. 1 No. 1 Landeshochschulgesetz (LHG).

a. Application procedure: The processing serves the sole purpose of handling the application procedure and thus the purpose of assessing your suitability and the possibility of possibly contacting you directly (if, for example, there are questions regarding your application). In the event of rejection, the data will be deleted as soon as they are no longer required for the purpose of carrying out the application procedure (no later than four months after rejection). In case of admission to the Graduate School, the data from the application form will be used as master data for membership administration.

b. Membership administration: The processing serves the administration of the membership and the organization of the Graduate School. Upon admission to the Graduate School, the data from the application form will be used as master data for membership administration. These data remain stored for the period of the existing membership and are then deleted.

3. your rights

You have the following rights vis-à-vis us regarding the personal data concerning you:

- Right to confirmation as to whether data concerning you is being processed and to information about the data processed, further information about the data processing and copies of the data (Article 15 DS-GVO).
- Right to have inaccurate or incomplete data corrected or completed (Article 16 DS-GVO).
- Right to erasure of data concerning you without delay (Article 17 DS-GVO)
- Right to restriction of processing (Article 18 DS-GVO)
- Right to object to future processing of data concerning you, where the data are processed pursuant to Article 6(1)(e) or (f) of the DS-GVO (Article 21 DS-GVO).

You also have the right to lodge a complaint with the supervisory authority about the processing of personal data concerning you by Karlsruhe Institute of Technology (KIT) (Article 77 DS-GVO).
